II. APPROVAL OF AGENDA:

A. Trustee Junker moved to accept the agenda. Trustee Meyer seconded the motion. Voice vote, 5 ayes, motion carried.

III. REPORTS OF COMMITTEES:

A. MAYOR'S REPORT:

1. The BBQ Contest was a huge success. Ten teams participated. Mayor Muniz read a letter of appreciation from ______. Thanks to all the sponsors the BBQ Contest is close to the break even point.

2. Homecoming is rolling along on schedule. Gideon Richardson wants to have tricycle races at the Homecoming. Mr. Richardson has will be the sponsor of the event. The races will take place both nights after the parade. There will be a \$20 entry fee and there will be prizes and trophies.
