I. The Regular meeting of the Board was called to order at 7:30 p.m. by Mayor Raymond Muniz.

II. APPROVAL OF AGENDA:

A. Trustee Miller moved to accept the agenda. Trustee Junker seconded the motion. Voice vote, 4 ayes, motion carried.

III. REPORTS OF COMMITTEES:

A. MAYOR'S REPORT:

- 1. Mayor Muniz presented Abi Sijhsa the Pride of St. Jacob Award for her 1st place finish in the long jump at the State Track meet.
- 2. Homecoming is July 17th and 18th and is moving along as scheduled. There will be Tricycle races this year. One hundred dollars will be awarded to the first place finisher, fifty dollars for second place and twenty-five dollars for third place. Helmets and pads will be provided.
- 3. The Mill Pond Committee will meet next Wednesday, July 8th.
- 4. Mayor Muniz reported they have been interviewing for a job opening in the public works department. Trustee Thompson questioned the need to hire a fourth public works employee. We could save at least \$30,000 by not filling this position. By saving \$30,000 this would go along way in paying for the 6th & Napoleon drainage project. Public Works Supervisors Biggins and Muniz both agreed that they needed the additional employee. Trustee Miller made a motion to give Mayor Muniz authorization to go ahead and hire someone to fill the position. Trustee Reilson seconded the motion. Roll Call Vote: Trustees Reilson, Junker and Miller voted Yes, Trustee Thompson voted No. Motion carried.
- 5. Mayor Muniz reported the mosquito sprayer had quite working and could not be repaired. A new sprayer was leased for \$1975.00 for the rest of the summer. If we wish to purchase the sprayer within the first 30 days of the lease, 100 percent of the lease would apply toward the purchase price. The remaining amount \$6,785 would be due 30 days, giving a total cost of \$8,760. If we wait until the end of the lease, October 15th to decide to purchase the unit, 90 percent of the lease price would apply towards the purchase price. The remaining amount of \$6982.50 would be due 30 days from the time we decide to purchase the unit. This would give a total cost of \$8,957.50
