II. APPROVAL OF AGENDA:

1. Trustee Meyer moved to accept the agenda. Trustee Robards seconded the motion. Voice vote, 5 ayes, motion carried.

A. MAYOR'S REPORT

C. WATER & SEWER COMMITTEE - REILSON:
