Tri Township is going to run a line from Walnut Road to the end of their district. We would be able to connect to this line and run it to Randy Gilomen. Ray also thinks that we should offer water to those that currently live in the surrounding area. Mayor Muniz also stated that there is potential for 60 to 80 more homes that would tap on if the planned development of a subdivision goes through. Our portion of the cost would be 13382.00 that includes labor. The total cost of the whole project is 29540.00 Tri townships portion is 16158.00.

Trustee Miller made a motion to extend water to Randy Gilomen not to exceed \$15000.00 and to hook on to Tri Township. Trustee Thompson second. Roll call, all in favor, motion carried.

3. Shawn and Brent have been registered to start taking water classes. Also Tim Biggins will be going to the annual water conference in February.
