Meeting called to order at 7:30 pm.

I. APPROVAL OF MINUTES AND AGENDA:

- A. Trustee Zahn moved to approve the minute's #14-08 for April 17, 2014. Trustee Beil seconds the motion. Roll call vote, all in favor, motion carried.
- B. Trustee Zahn moved to approve the agenda #14-09 for May 1, 2014. Trustee Gavlick seconds the motion. Roll call vote, all in favor, motion carried.

II. COMMUNICATIONS:

- A. Mayor Schiefer stated that the Board meeting on June 5, 2014 will be interfering with preparation for Jakey in June. He requested we change the date or the location of the meeting. Trustee Tolbert made a motion to move the June 5, 2014 meeting to the Village Hall. Trustee Zahn seconds. Roll call vote, all in favor, motion passed.
- B. Jamie Henderson with Henderson Associates Architects presented the Professional Services Proposal to the Village Board for the design and execution of the Village Hall addition located at the Activity Center. The Engineer and Architects scope of work and fees approximately \$32,000.00
