Meeting called to order at 7:30 pm.

I. APPROVAL OF MINUTES AND AGENDA:

- A. Trustee Ross moved to approve the minute's #14-13 for July 10, 2014. Trustee Richeson seconds the motion. Roll call vote, all in favor, motion carried.
- B. Trustee Ross made motion to approve agenda #14-14 for July 24, 2014. Trustee Richeson seconds. Roll call vote, all in favor, motion passed.
- II. COMMUNICATIONS: Mayor Richard Schiefer, and the Board members, observed a minute of silence in memory of former Mayor Ed Kelly who recently passed away.Gary Gustafson & Neil Odle, with Da-Com, provided a presentation and information for a Document Management System. Gary explained the benefits of the system regarding the storage of records electronically.

- **IV. HOMECOMING REPORT:** Marlin Fohne submitted the report of the cash deposits for July 18 & 19th homecoming.
- V. TREASURER REPORT: Treasurer Rehg stated that while contacting some banks, she was advised there are programs for college students to look for grants and write them for Municipalities at minimal cost. The contact information was given to Trustee Gavlick, chairman of Community Development/Health. Discussion ensued to pay off three loans at the State Bank of St Jacob, # 2380603, 2380719 & 2401803. Treasurer Rehg said the early pay-off would save the village approximately \$8000.00. Trustee Ross made a motion to approve the payoff of State Bank of St Jacob Loan # 2380603 in the amount of \$45,113.56, Loan # 2380719 in the amount of \$26,960.89 & Loan # 2401803 in the amount of \$21,774.47, totaling \$93,848.92. Trustee Richeson second. Roll call vote, all in favor, motion passed. The loan with the Bank of Edwardsville was tabled until Treasurer Rehg secures the actual pay off amount.

VI. COMMITTEES:

- A. COMMUNITY DEVELOPMENT/HEALTH:
 - 1. Trustee Gavlick deferred to Mayor Schiefer regarding the Community Block Grant. The Mayor reported that the letters have been sent out for the survey of the residents who are a part of the grant.

- 2. Trustee Gavlick reported he will be contacting Charlie Juneau regarding the cost of repair/replacement as opposed to new construction applications in the Village's "ADA Self Evaluation and Transition Plan".
- B. WATER AND SEWER:
 - 1. Discussion ensued regarding water & wastewater operation classes for village employee Greg Koberna. The required classes, through SIUE, are only available at Geneva, IL. at this time. Trustee Richeson made the motion to approve Greg Koberna to attend the classes in the amount of \$550.00 and the necessary travel expenses, with the agreement that Greg would stay with the Village as an employee for one year.

- C. POLICE:
 - 1. Trustee Beil stated the Police Officers did a good job at the Homecoming. She deferred the police report to Captain Souders who stated that the Homecoming was a huge success and went well. His monthly report included that 5 tickets were issued, an identity theft case had been reported and two signs from the beer trailers at the homecoming were reported missing. The cases are being investigated.

Trustee Beil seconds. Roll call vote, 2 nays (Trustee Ross & George Gavlick), 2 ayes, tie vote Mayor Schiefer then voted nay. Motion denied.
 - 4. Trustee Ross made the motion to approve the authorization for Treasurer Rehg to have access to all banking financial information for the Village. Trustee Gavlick second. Roll call vote, all in favor, motion passed.
