- VI. A report for November and December was presented.
  - 1. In November, a small amount of property tax was received and as it will till March. As such, most of our funds, other than the Proprietary Funds, may operate at a deficit on a monthly basis. The deficit in the General Fund is because of capital outlay to the new police car and repairs to the Activity Center. Those totaled \$130 thousand. The Insurance Fund paid the annual premium. The Sewer Fund showed a profit due to \$10 thousand in tap on fees.

In December there was a slightly greater amount of property taxes. The General Fund is the only fund showing a deficit for the month. Property taxes were sufficient to keep the other funds afloat. Property tax revenues were insufficient to keep the Police and Streets sub funds in the green. There was also a large deficit in the Public Grounds sub fund due to monies being transferred to the Debt Service and Debt Reserve accounts. Those payments totaled \$17 thousand. Revenues exceeded expenditures in the Sewer Fund because of another \$10K in tap on fees. For the eight months of the fiscal year the only funds in the red are the General Fund and the Motor Fuel Tax Fund. Expenditures exceed revenues in each sub fund of the General Fund except Ordinance and Finance which has more revenue sources than the others. The MFT deficit is because of the street repairs last summer. The monies from the MFT fund were not eligible to be spent as they were so there will have to be a reimbursement. The year-to-date deficit overall is \$118 thousand.

The cash balance is \$808 thousand as of December 31, 2017.
