

**ORDINANCE NO. 17-589**

**AN ORDINANCE OF THE VILLAGE OF ST. JACOB AMENDING CHAPTER 4 (BOARDS AND COMMISSIONS) BY ADDING ARTICLE III (ST. JACOB JAKEY IN JUNE COMMITTEE) TO THE REVISED CODE OF ORDINANCES OF ST. JACOB, ILLINOIS**

**WHEREAS**, it is the desire of the corporate authorities of the Village of St. Jacob to create a Jakey in June Committee to assist in future recommendations for the regulation, control, and administration of the annual Jakey in June event under the control of the Village; and

**WHEREAS**, it is in the best interests of the Village of St. Jacob to adopt an ordinance amending the Village Revised Code of Ordinances to add rules and regulations pertaining to the membership and duties of the St. Jacob Jakey in June Committee.

**NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ST. JACOB, ILLINOIS, AS FOLLOWS:**

**SECTION 1:** Chapter 4, Article III is hereby adopted and added to the St. Jacob Revised Code of Ordinances to read as follows:

**ARTICLE II**

**ST. JACOB JAKEY IN JUNE COMMITTEE**

**4-3-1** **COMMITTEE ESTABLISHED.** There is hereby established a committee in and for the Village to be known as ***THE ST. JACOB JAKEY IN JUNE COMMITTEE.*** This Committee shall organize and oversee the annual Village Jakey in June event.

**4-3-2** **MEMBERSHIP; APPOINTMENT; ORGANIZATION.** The St. Jacob Jakey in June Committee (the "Committee") shall consist of seven (7) individuals appointed by the Mayor with the advice and consent of the Village Board of Trustees. The Committee members shall elect a chairperson, vice-chairperson and secretary from the

duly-appointed members. The Mayor shall be an ex officio, non-voting member of the Committee. Members need not be Village residents.

**4-3-3**            **TERMS OF OFFICE.** Members of the Committee shall serve for terms not to exceed one (1) year, being eligible for reappointment as shall be specified by the Mayor with the advice and consent of the Village Board. The initial appointments to the Committee shall serve until August 31, 2018 and subsequent annual appointments to the Committee shall be made by the Mayor, with the advice and consent of the Village Board of Trustees, at the first Village Board meeting in September.

**4-3-4**            **DUTIES OF THE COMMITTEE.** The duties of the “Committee” shall be as follows:

(A)            Develop an annual budget for the Jakey in June event to be recommended to and approved by the St. Jacob Village Board;

(B)            Involve departments of the Village government and interested members of the community as much as possible in its work, and to encourage complementary activity with civic organizations, local businesses, schools and other agencies and organizations;

(C)            Carry out a public information and advertisement program for the Jakey in June event;

(D)            Meet on a monthly basis – or as needed with proper notice – at a time and place to be determined by the Committee;

(E)            Take other appropriate and reasonable actions to make the Jakey in June event successful;

(F)            Make periodic presentations of any proposals and contracts for the Jakey in June event to the Village Board of Trustees in order to keep the Village Board of Trustees fully informed of the progress of the event;

(G)            Present for approval to the St. Jacob Board of Trustees any recommendation or decision affecting the financial and security aspect of the Jakey in June event and/or potential liability of the Village.

**4-3-5**            **COMPENSATION.** The members of the Committee shall serve without compensation.

**4-3-6**            **FACILITIES FOR MEETINGS.** The Village shall provide a meeting place in the Village Hall or some other designated Village owned facility.

**4-3-7**      **PROFITS FROM EVENT.** The Village shall apply all of the profits generated from the annual Jakey in June event to the maintenance and improvements of the Village Activity Center.

**SECTION 2:** This Ordinance shall be in effect upon its passage, approval and publication as provided by law.


**SECTION 3:** Any and all Ordinances, sections, or subsections of Ordinances in conflict herewith are hereby repealed.

**SECTION 4:** This ordinance shall expire one year from its effective date unless otherwise extended by a vote by the Village Board of Trustees.


