

ORDINANCE NUMBER 17-

**AN ORDINANCE AMENDING
CHAPTER 4 OF THE REVISED CODE OF ORDINANCES
REGARDING THE HOMECOMING COMMITTEE**

WHEREAS, The Village Board of Trustees for St. Jacob, Illinois as a Homecoming Committee responsible for organizing the annual Homecoming Festival in the Village of St. Jacob, and

WHEREAS, it is the decision of the Board of Trustees to invite nonresidents to serve on the Homecoming Committee for the Village of St. Jacob, Illinois.

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE BOARD OF TRUSTEES OF THE VILLAGE OF ST. JACOB, STATE OF ILLINOIS, AS FOLLOWS:

SECTION 1: Section 4-2-2 and any other amendments of the Revised Code of Ordinances of the Village of St. Jacob stating the number of members on the Homecoming Committee to be nine members are amended by deleting therefrom the original language and inserting in lieu thereof the following language:

4-2-2 Membership; Appointment; Organization. The St. Jacob Homecoming Committee (the "Committee") shall consist of no fewer than nine (9) and no more than fifteen (15) individuals appointed by the Mayor with the advice and consent of the Village Board of Trustees. The Committee members shall elect a chairperson, vice-chairperson, and secretary from the duly-appointed members. The Mayor shall be an ex officio, non-voting member of the Committee. Members of the Homecoming Committee need not be Village residents.


SECTION 2: Any other ordinances or provisions of the Revised Code of Ordinances of the Village of St. Jacob that are inconsistent with Section 1 shall be and are amended to conform thereto. This ordinance shall become effective upon its passage, approval as required by law.


