### **ORDINANCE NUMBER 18-**

# AN ORDINANCE AMENDING CHAPTER 16 OF THE REVISED CODE OF ORDINANCES REGARDING HEATH

WHEREAS, The Village of St. Jacob, Illinois, has the authority to negotiate the cost of garbage, refuse, and recycling collection and removal for the residents of St. Jacob in addition to certain nonresidents receiving such service; and

WHEREAS, it is necessary, desirable and in the public interest that the Village increase its recycling rates,

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE BOARD OF TRUSTEES OF THE VILLAGE OF ST. JACOB, STATE OF ILLINOIS, AS FOLLOWS:

**SECTION 1:** Section 16-1-8 and any amendments, of the Revised Code of Ordinances of the Village of St. Jacob regarding service charges and fees, is amended by deleting there from the original language and inserting in lieu thereof the following language:

**16-1-8** Charges for Service. Service charges to be collected from and paid to Village by persons, firms, and corporations receiving refuse, garbage, recyclable and yard waste collection service from this Village shall be as follows, to-wit:

- b) Recycle: Automated 1x/EOW with up to 2, 95G carts. Up to 2 carts provided. Additional recycle cart: \$4/month.
- c) Yard Waste: Mandatory year long, unlimited containers.

SECTION 2: This ordinance shall become effective upon its passage, approval as required by law.
