**ORDINANCE NUMBER 20-614**  
**AN ORDINANCE FOR THE VILLAGE OF ST. JACOB,**  
**MADISON COUNTY, ILLINOIS, TAX LEVY ORDINANCE**

An ordinance levying taxes for all corporate purposes of the Village of St. Jacob, Madison County, Illinois, for the tax year of 2020, and for the Fiscal Year beginning April 1, 2021 and ending March 31, 2022.

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE BOARD OF TRUSTEES OF THE VILLAGE OF ST. JACOB, STATE OF ILLINOIS, AS FOLLOWS:


Section 1: That the amount hereinafter set forth, or so much thereof as may be authorized by law, and the same are hereby levied upon all property subject to taxation within the village as that property is assessed and equalized for the current year, and for such purposes as: General Corporate, Audit, Police Protection, Social Security, Street Lighting, IMRF Fund, and Insurance for the Village of St. Jacob, for the fiscal year beginning April 1, 2021 and ending March 31, 2022.

Section 2: That the amount levied for each object and purpose is placed in a separate column under the Heading "Amount to be Raised by Tax Levy," which appears over same being as follows, to-wit:

Section 3: That the Village Clerk shall make and file with the County Clerk of said County of Madison, on or before the last Tuesday in December, a duly certified copy of this Ordinance.

Section 4: That if any section, subdivision, or sentence of the Ordinance shall for any reason be held invalid or unconstitutional, such decision shall not affect the validity of the remaining portion of this Ordinance.


Section 5: That this Ordinance shall be in full force and effect after its adoption, as provided by law.
